St. Peter's Episcopal Church Annual Parish Meeting January 22, 2023

Pre-meeting: The meeting was held in-person this year. Location of the meeting was in the Parish Hall. A breakfast pot luck was held after a 9:00 a.m. service and just before the annual meeting.

Quorum Established: The Clerk noted that at the time of opening of the meeting, a total of 30 voting members were present, establishing that a quorum of those eligible to vote, nominate, and be nominated were present.

Invocation: The invocation was led by the Reverend Anne Fraley.

Meeting Called to Order: The meeting was called to order at 10:30 a.m. by the Reverend Anne Fraley.

Presentation and Adoption of Roll of Voting Members/Quorum: A "List of Those Eligible to Vote, Nominate, and be Nominated for Vestry Positions" was provided in the "Annual Report of St. Peter's Episcopal Church for the Year 2022." No changes were made to the voting list.

Minutes from the 2021 Annual Meeting: Minutes from the 2021 Annual Meeting are included in the 2022 Annual Report. There were no corrections offered. Motion was made by Diane Fortuno and seconded by Dora-Lee Ober to accept the minutes of the 2021 Annual Meeting. Motion carried.

Treasurers Report: The Treasurer's report was included in the 2022 Annual Report. Motion was made by Diana Rios to accept the Treasurer's Report for 2022. Diane Fortuno seconded this motion. Motion carried.

Reports on Parish Life and other Commission Reports: Copies of parish life and commission related reports are presented for review in the 2022 Annual Report.

Property Commission – Anne announced for Ken Fraley that the Property Commission lost some of its more active members. Members do not have to come to all meetings and only have to be willing to help out periodically. All parish members are encouraged to pitch in and help with projects even if they are not a member of Property.

Question: A question was asked inquiring about who is responsible for cleaning up the black foot marks on the parish hall doors. It was further asked if it was left by the boy scouts and can we ask them to clean them up?

Answer: Anne answered that we are not sure who made the marks but we can ask the boy scouts to pitch in and clean up after themselves. It was determined that a magic eraser can be used to clean up the marks. Any requests to paint the doors will need to be reviewed by the head of the property commission.

Invitation for Other Reports: The Reverend Anne invited corrections or additional reports to come forward. None were presented.

New Business:

2023 Budget: The 2023 Budget was previously approved by the vestry earlier this month at the January 9, 2023 vestry meeting. A copy of the 2023 Budget was included in the "Annual Report of St. Peter's Episcopal Church for the Year 2022".

Greg explained that the 2023 budget looks and feels similar to the 2022 budget. The parish was reminded of the challenges to our financial outlook but noted that last year we had a balanced 2022 budget with both Income and Expenses at \$199,000, respectively. They were further reminded that balancing the 2022 budget relied on withdrawing \$43,000 for the endowment. In previous years we did not touch the endowment to balance the budget. He further emphasized that this is not something we want to do in the long term. However, in the short-term it does allow us to not have to cut too many expenses, which run in total around \$200,000 annually. Most expenses are fixed consisting primarily of salaries, utilities and property. Pledges for 2022 were budgeted at \$145,000, creating a hole that was closed with the \$43,000 from the endowment. Greg noted that actual 2022 pledges came in better than budget at \$155,000.

Looking towards 2023, Greg presented the Budget as follows:

Total Income\$185,000Total Expenses\$203,000Net Loss\$18,000On the income side, total income is budgeted at \$185,000. The main components of income are broken down as
follows:Total Pledges\$145,000Endowment Income\$24,000Other\$10,000-\$15,000

Greg noted that despite losing members during 2022, we received more actual pledges for 2023 than what we received for 2022, relying less on estimated pledges. Given this information, Greg is highly confident of us receiving the full \$145,000 of budgeted pledges for 2023. Income from building use has been very good, coming in at \$3,000 in 2022. Also, included in budgeted income was \$4,000 of income from fundraising, encouraging revenue generation from outside sources.

On the expense side, there are still \$200,000 of expenses which gives rise as to what to do with the endowment. It was decided not to give an appearance of a balanced budget and proposed to decrease the amount we withdraw from the endowment to \$24,000 for 2023 (\$2,000 per month). Greg stated that withdrawing \$24,000 per year from the endowment is more than what we should be taking per the Diocese. Based on the endowments current market value of \$360,000, we should only be withdrawing \$15,000 per year. In the end, a \$18,000 net loss was budgeted. Greg explained that it does not make sense to take \$18,000 more out of the endowment just to look like we have a balanced budget. It was further explained that the actual short fall is \$30,000 in our finances. The endowment can bridge us over these tough years but in the long term we need to diversify our income stream, looking at income generated from building use and fund raising as additional sources.

For 2023, the salaried position for organist was budgeted at \$0. Tim held this position but left the Church midyear in 2022. This position remains unfilled, resulting in expenses for organist coming in lower than budget for 2022. Moving forward for 2023, there is a line item for guest organist budgeted at \$6,000, funding only $\frac{1}{2}$ years' worth of music. It was mentioned that salary expenses can be reduced somewhat further by cutting Anne's hours by 5%. This has not happened yet but remains a possibility for 2023.

Free cash is at \$50,000. This is a little below where we should be. Ideally, we should have free cash of \$60,000, equating to three months' worth of liquidity. Greg mentioned that we do have the endowment that can be utilized if we run into a liquidity problem. In the end, Greg did emphasize that raising /diversifying income in 2023 needs to be a top priority. He asked everyone in the parish to please exceed their pledge and to those who don't pledge, please give.

Time was given for questions and comments related to the Budget Presentation:

Question: How many outside groups do we have consistently used the building?

Answer: Five groups: Al-Anon, Scouts, Make Food Lovely and Wednesday Afternoon Group. Make Food Lovely provides \$2,400 of the \$3,000 of rental income generated for building use.

Question: Is there a way we can see how much the parishioners give to the various outreach projects?

Answer: This can be done but it relies on parishioners informing the Church of the donation and what it is for. Anne mentioned that there is a place in the software database management system for in-kind donations. That amount would be generated with the individuals pledge statement at the end of the year. It would help the church report as to where the money is going. Greg further noted that although we don't budget for outreach, money does flow in and out of the church for outreach projects.

Question: Would we be able to do a craft fair in the autumn season closer to Christmas?

Answer: We do a vendor fair in the spring but doing a craft fair in the autumn months can be considered. Ann stressed where we run into a problem getting enough volunteers to help run these events. During the autumn months, everything gets busier especially with parish life and mission.

Comments: Barbara Hoff mentioned that we need to get a fund raiser committee to come together to come up with ideas, work on ways to get more building use and raise funds outside of the church. It was also mentioned that we need to review what we charge for building space. It was also mentioned that our space has no stairs, which would be looked upon favorably by some groups. It was determined that this will be an ongoing conversation.

The Reverend Anne Fraley made a motion to approve the Vestry Slate by a vote of acclimation. Motion passed unanimously.

Presentation for Nomination for Diocesan Delegate and Alternate Diocesan Delegate: Nominations for Diocesan Delegate and Alternate Diocesan Delegate was posted in the January 18, 2023 Light Breezes dated January 18, 2023 and is as follows:

The Reverend Anne Fraley made a motion to approve the nominations for Diocesan Delegate and Alternate Diocesan Delegate by a vote of acclimation. Motion passed unanimously.

Anne took this time to thank Greg Malone and Barbara Hoff for their service and leadership in the positions of Treasurer and Senior Warden, respectively. She announced to the Church that Greg is relinquishing his role as treasurer this coming year, a position he held for 16 years. She also announced that Barbara Hoff will be leaving the position of Senior Warden to take on the position of Treasurer. Anne also individually named and thanked everyone in the vestry for their service in 2022.

Rectors Remarks: Anne mentioned that she hit most of the highlights of her remarks during the sermon as to where we are and where she sees us going. She can't paint a picture of what that looks like but she knows God is in it and we are faithful and that is two essential components for moving forward. She further remarked that we have thoughtful and creative minds in this group and she looks forward to hearing thoughts and ideas to work with. Anne suggested that members invite friends to church and hopefully they will call this church home. She stressed that this is how we grow.

She mentioned that when she initially came to St. Peter's as rector, one of the items in her letter of agreement was that after 5-years she was entitled to a sabbatical. She informed the parish that she will be taking this sabbatical this spring right after Easter for a period of 3-months. The Reverend Ben Brockman will be serving as minister for most of the Sundays. The vestry, wardens and Diane will be here to "steer the ship". Jessie will be able to provide clergy continuity. It is a time for Anne to get renewed off site and for the parish to have an opportunity to renew and reflect.

General Discussion: None.

Announcements:

- Dora-Lee announced that she would like to start up a Bible Study in her home. She spoke to some people prior to the meeting who are interested. Anyone who is interested should contact her. All are welcome.
- The parish was asked if anyone would be interested in a Lentin Book Study that will take place after services. There was a show of interest from some members.
- Diane reminded everyone at the meeting that if they haven't done so, please pick up their envelopes.

A motion was made by Barbara Hoff to withdraw \$12,000 from the St. Peter's General Fund #18047 in order to cover the cost of sewer repairs. Mark Bell seconded this motion. Motion passed.

A motion was made by Dick Hubeny to allocate any donations related to the Thanksgiving Meal for Seniors to Outreach Expenses. Ingrid Menon seconded this motion. Motion passed.

A motion was made by Barbara Hoff to set the annual meeting date for January 21, 2024. Bill Hartley seconded this motion. Motion passed.

Vestry Meeting December 11, 2023 via Zoom

Barbara Hoff made a motion that the Vestry of St. Peter's Church, South Windsor, elects to retain our current annual spending distribution of \$24,000 from our Estate of Nancy C Braender Restricted Fund (Account 21108). These funds will be disbursed to St. Peter's in equal monthly payments of \$2,000. Tara Fornuto seconded this motion. Motion passed.

Whereas the Rev. Anne Fraley is employed as a minister of the Gospel by St. Peter's Episcopal Church, South Windsor, CT, the vestry resolves that the total compensation to be paid to the Rev. Fraley during 2024, that \$8,000 be designated a parsonage allowance within the meaning of that term as used in Section 107 of the IRS Code of 1986 as amended. Barbara Hoff seconded. Resolution passed.

Treasurer's Report

From a financial perspective, we did reasonably well in 2023, ending up almost exactly where we expected. Unfortunately, our expectation was that our expenses would exceed our income by approximately \$18,000. As a result, we had to draw down some of our savings to cover the difference.

Income and Expense Report

Income: Let's start with the bright side. You, our members, exceeded your pledges by \$13,000. A huge "thank you" to everyone who contributed – whatever amount it was. On top of that, you helped us with various fundraisers, especially the Vendor Fair and RaiseRight. One other major source of income was almost \$5,100 from Building Use fees. As a reminder, we also withdrew \$2,000/month from our endowment (more on this when we talk about the balance sheet).

Expenses: Our expenses also came in almost \$13,000 more than expected. Most of this was related to plumbing expenses, including an early attempt to solve the sewer pipe blockage and then two months later removing the broken sewer pipe and replacing it. We also now have new dishwashers in the church and the rectory plus a new microwave in the rectory. At one point, I told Rev. Anne that I was going to stop taking her calls because they were getting too expensive! To reduce a few of our monthly costs, we switched from Cox to Frontier and switched our electrical supplier from Eversource to Constellation mid-year. This had some impact on our monthly costs in 2023 and we expect will show more obvious dividends in 2024.

Balance Sheet

Current Assets: The combined value of our Checking Account and Money Market accounts is lower this year by about \$17,000, reflecting the amount of the deficit. Our Escrow (funds we set aside from an accounting perspective) is lower because we are no longer earmarking any funds for Sabbatical or Altar Guild. We used the Sabbatical funds to cover our costs when Rev. Anne was on sabbatical this summer. Going forward, we will include flowers and other worship-related items previously managed in a separate Altar Guild account in our regular offerings and operating expenses.

Endowment: The value of our Endowment (shown under Investments-Other Assets) was approximately \$367,200 at the end of last year. This year it is \$365,900, even though we withdrew \$24,000. The increased value of the investment over the year and the income the account earned were sufficient to offset most of our drawdown.

Rector's Report

Each year the rhythm of the parish is driven by liturgical seasons and Feasts, parish traditions and rituals. 2023 was no different! We finally enjoyed a year uninterrupted (mostly!) by pandemic restrictions and cautions and began to live with some confidence into the possibilities of what God was calling us to do as followers of Jesus in South Windsor. We also continued to adapt to the newer normal of a smaller congregation, with fewer people to participate in events or offer leadership and reduced financial resources. And yet, despite some of the challenges we faced, in some ways it feels like we are stronger than ever. For that my gratitude runs deep, and my enthusiasm for what lies ahead is intact.

The most significant liturgical innovation is the success and popularity of our monthly Interactive Church worship. Generally offered on the first Sunday of the month, we gather in the parish hall in small groups around tables to take up questions inspired by the lectionary texts of the day or the liturgical season underway. We have gotten to know each other better, given voice to questions and perceptions, and considered new ways of understanding the sacred texts and traditions at the core of our life theologically.

We also enjoyed a vibrant and well-attended Blessing of the Animals in October. Close to thirty people from the parish and the community (and Colchester!) brought their pets to share in a celebration of our relationship with the dogs, cats, and horses that infuse our lives with joy and love. One community member brought a photo of the cat she had lost earlier in the year, and was so moved by the opportunity to have the cat's memory blessed that she took the time to write, several months later, to share how meaningful the occasion had been for her. The experience embodied what Mother Teresa referred to as "doing small things with great love." We are honored to be a vessel of God's care for creation on such an occasion.

We continued to serve members of the community through collections of school supplies for kids in need, food for those facing food-insecurity, support for Harford Bags of Love in bringing awareness to the plight of the unhoused, a Thanksgiving meal for area seniors (107 meals served!), a team of volunteers that prepares a hot meal each month for an East Hartford ministry that feeds the hungry, and the provision of gifts for the children of a local family at Christmas. Deacon Jessie was also instrumental in reviving Heavenly Hugs, a ministry of knitting and crocheting for others.

Formationally we enjoyed two well-attended and engaging book studies, one during Lent and the other in the fall. In the first we used Henri Nouwen's *Return of the Prodigal Son*, a reflection on his engagement with Rembrandt's painting of the same name. The book took us into spiritual and theological depths we would likely not have explored on our own individually, and our conversations were rich and vulnerable. In the fall we read through Mark Yaconelli's *Messy Spirituality*, an entirely different experience of exploring the ways in which we encounter and respond to God's presence in our lives. These occasions offered us opportunities to share our faith, our questions, and our struggles in community, and blessed the participants.

Relationally we enjoyed some of our usual traditions: the Shrove Tuesday Pancake Supper, the Grad Dinner, a Progressive Dinner, and the Parish Christmas Party. An unexpected plumbing crisis necessitated postponing the fall Spaghetti Dinner, but we are geared up and ready to enjoy that rescheduled repast soon. We also introduced a Game Night and a Potluck Picnic, and the women of the parish revived a fun Ladies Night. Each occasion provided an opportunity to enjoy and deepen existing relationships, and to build new ones.

The shape of the year was slightly different for the parish and for me by virtue of my sabbatical from April to July. I am deeply grateful to St. Peter's for the opportunity to have this time away, which was rich in a multitude of ways. I was deeply moved by the laying-on-of-hands with prayers on the Sunday before I began the sabbatical and felt sustained by those prayers and intentions. I am also indebted to the Rev. Bennett Brockman for coverage of priestly duties in my absence, Diane Fornuto's competent management of the office, Jessie's pastoral and liturgical presence, and the leadership of the Wardens and Vestry "in the gap."

St. Peter's thrives because faithful people show up: for worship, for programs, to fold bulletins, change lightbulbs, prepare the altar for worship, serve meals, run our live-stream, wash dishes, shovel snow, make deposits at the

bank, and more. We are able to respond to God's call to us to serve in the name of Christ because the individuals who make up our community give freely and gladly of themselves. I am so grateful for each of those acts of service, expressions of generosity, and prayers of connection.

I also want to acknowledge a few people whose efforts, often "behind the scenes," ease the tasks that are part and parcel of being a community of faith in this day and age.

He probably can't count the number of hours he has put into website problem-solving, maintenance, and innovation, nor detail the extent to which he has explored the nuances of technology to make it possible for us to broadcast our worship, but Dick Hubeny has gone far above and beyond any expectation of what it means to offer technical support to the parish. His attention to the minutiae of that part of our common life frees my energy and attention for other aspects of ministry (not to mention that I'm pretty clueless about such things), and it isn't possible to underscore the value of that.

Likewise, Erik Barber has devoted hours upon hours of untangling the electronic complexities of our sound system, and our wifi. He has probed the guts of equipment, rebuilt electrical components, and rewired entire systems. The application of his expertise in this area has been invaluable, and he has worked with Dick to bring us closer to a place of consistent delivery in "worship technology."

Last winter, when budget cuts fell heavily on our ability to pay for musical accompaniment in worship, Amy Hubeny felt called to offer her keyboard gifts to provide accompaniment twice a month. Amy's offering is a gift of music and of spirit, and I can't begin to describe the ways she has brought grace to my life, and to our worship, as a result.

Another person who devotes countless hours to supporting our parish life is Barbara Hoff. She devotes considerable time to her role as treasurer, but she also tends to our gardens and landscaping, helps declutter the things that accumulate around the church, and steps in to fill the needs that appear here and there as we bump through our days. These are just the things I know about. Barbara has a way of offering herself in a "stealth" capacity that springs from a spirit of love, selflessness, and generosity.

Thank you to each of these members for the time and talent they offer that make our life easier, and free us to serve God, our community, and each other unburdened by what might be considered tedious details.

Finally, I want to acknowledge the support of our Parish Administrator, Diane Fornuto. Our members experience much of the work that she does on a regular basis: produces the weekly worship bulletin, sends email notices and reminders, and coordinates the Sunday Rota of volunteers. It's what you don't see that is appreciated by me beyond measure. She is a sounding board for ideas, regularly asks, "what can I do to help?" when administrative details accumulate and helps me think through logistical quandaries when the need arises. And more! She is an invaluable support to the work I do as rector and to members of the parish in their various roles and responsibilities. Thank you, Diane!

Swedish diplomat and second Secretary General of the United Nations, Dag Hammarskjöld, is famous for having expressed prayerfully: "For all that has been, THANKS, for all that is to be, YES!" I echo those sentiments as we stand at the hinge between years.

Peace by Piece Quilters

Our quilting group has been in existence since 2007 and was created to give quilts to those going through lifechanging illnesses/treatments, surgeries, and natural disasters. We also make other items: for servicemen overseas, masks during the pandemic (over 5000), and small (4"squares and hearts) "Pocket Prayers" that can be put in your purse/pocket/backpack (to rub away your cares). All of our items are Blessed when finished, and are available BY REQUEST ONLY, since we keep records of where our quilts go 'to live'.

In 2023, we gave out 29 quilts, including 20 that went to children displaced by the earthquake in Syria/Turkey. This year alone, we have finished 15 and have 7 more in progress. We currently have 14 waiting to bring comfort to someone. There are very few instances that we would have to deny sending a quilt out, due to the capabilities of our small group, but for those few, we will keep them in our hearts and prayers. St. Peter's Outreach Team (SPOT)

During 2023 we had 8 members: Sandy Bell, Amanda Bierkan, Anne and Ken Fraley, Robert McBeth, Tara Fornuto and Diane Fornuto, as well as the numerous volunteers who have made 2023 a successful year for SPOT. Blessedly, we were joined by Deacon Jessie Akerson. Thank you to all members and volunteers for their great ideas and hard work.

In February we held our first ever commission retreat and decided to change our name to SPOT - St. Peter's Outreach Team. We also established a mission statement: "The mission of SPOT is to respond to community needs as an expression of God's love."

During 2023 the Mission Commission supported 13 successful outreach projects as noted below. We continue to work to support our local community as well as broader concerns throughout the world. Below is a list of our projects.

Care Bags: We filled Ziplock bags with items such as toiletries, socks, hand warmers, snacks and \$5 gift certificates to Dunkin Donuts or McDonalds to carry in cars for donation to needy and homeless people.

South Windsor Food Bank: We have an ongoing collection of non-perishable food and supplies to support the food bank. Ingrid Menon has graciously agreed to resume her ministry of bringing the items to the food bank.

Free Little Pantry: In partnership with BSA Troop 682 we provide ongoing support of the outdoor food pantry located at the front of the church. In order to increase the amount of food donated to the pantry we are now posting in the bulletin a reminder along with a suggestion of three items for the week.

Pantry Supporters recognition: In September we held a blessing and small reception for those who contribute to the little pantry.

Earth Day Tree. With the help of a donation from The Garden Barn and a parishioner, and under the direction of Ken Fraley, we planted a Dogwood tree in Never's Park near the dog park. We had hoped to have a tree planting service, but the weather interfered with that plan.

Friendship Kitchen. Under the direction of Ken Fraley, a group of members are preparing meals one Monday per month for a soup kitchen in East Hartford. Anyone who wants to get involved should see Ken.

Back to School Project: Using an Amazon Wish List and stickers in the sanctuary, we collected an incredible amount of back-to-school items which were delivered to the South Windsor Community Center.

Crop Walk: Thanks to Amanda Bierkan's organizing efforts, we raised funds to help food-insecurity locally and globally.

Hartford Bags of Love Sleepout Breakfast: Each year Harford Bags of Love holds a sleepout to raise awareness of homelessness. For several years we have been providing breakfast for the participants the following morning. This year we provided breakfast for approximately 15 people, a smaller number than usual probably due to the warmer weather.

Thanksgiving Bags: The Department of Human Services sent a flyer asking for bags of specific foods for delivery to residents in need. We had hoped to provide two bags/boxes but your generosity was, as usual, overwhelming. We provided an abundance of food!

Thanksgiving Meal: We prepared 107 meals which were served here, picked up, or delivered to local seniors and the South Windsor Police Department.

South Windsor Christmas for others: We adopted six children through the town of South Windsor Human Services Department and provided all the gifts that were on their wish list.

Fishin' For Mission: Under the leadership of Amanda Bierkan, plans are underway to finally have the fish dinner during Lent that was cancelled at the outset of the Covid epidemic in 2020. I'm sure she could use some help, so speak to her if it is something that interests you.

As your Outreach Team we are happy to be St. Peter's hands in spreading the love of Christ to our neighbors and are trying to execute our mission statement. We look forward to continuing our recurrent projects and creating new ones. We meet on the second Sunday of the month and invite anyone interested in outreach to join us. As always, we welcome new members or visitors to our meetings.

Property Commission

The Property Commission had a busy year with both planned, and unplanned activity!

Early in 2023 we purchased a new shed to replace the existing shed that is a bit worse for wear (and which we anticipate tearing down). The new shed was assembled on the concrete pad where the dumpster was situated. The contents of the old shed were relocated to the new one by members of Troop 62 during a spring cleanup day.

I want to extend my thanks to Tom Morelli and Dick Hubeny for their time and labor assisting in the assembly of that project.

We had a water leak in the sanctuary roof that prompted us to repair the steeple. Upon repair of the steeple we discovered that the leak was in the shingles, and that was repaired.

We had a damaged urinal in the office wing men's bathroom which we repaired and remounted.

We had two incidents of a plugged sewer line in the education wing that led to the discovery of a compromised sewer line. The affected pipe was replaced, and we believe this will address the problem.

The kitchen dishwasher had to be replaced when it was determined that the pump had failed. The cost to replace the pump was sufficiently high to prompt us to recommend that the dishwasher be replaced with a new one. We did so in the fall. Thanks to Will Prokop for his assistance installing the new dishwasher.

The rectory also had two appliances replaced (dishwasher and microwave) when the existing ones failed; the rectory had some gutter work done as well.

Thanks to the Property Team for their assistance with all of our projects, big and small, and for the attention to detail they apply in caring for our building and grounds: Erik Barber (Junior Warden), Dick Hubeny, Tom Morelli, Will Prokop, and Diana Rios.

Communications & Technology

There have been numerous improvements in St. Peter's technology and communications during 2023, most notably with the Internet, Website, Streaming and Sanctuary Sound System. Our primary means of communication is St. Peter's Facebook page. If you have a Facebook account, follow us on Facebook for timely notifications of events, photos, services and cancellations.

Internet & Phone

- In May, we switched from COX to Frontier fiber-optic for our Internet and Phone. Besides substantial cost savings, we realized improved reliability and a 10x speed gain from 50 Mbps to 500 Mbps.
- WiFi access has been extended throughout the entire church: office wing, sanctuary, parish hall and education wing.
- To improve WiFi security, two new WiFi guest accounts were created (SPEC_Guest and SPEC_Guest5G). The Guest accounts are for church members and other users of our facility who require internet access. The Guest account password is posted in the Parish Hall. The password for the main SPEC account was changed to limit access to church personnel and office equipment only.
- The Fire security system was converted from voice over internet phone lines (VoIP) to cellular communication for improved reliability. This allowed us to cancel the 2 dedicated fire alarm phone lines for additional cost savings.

Website

Our website was suffering from excessively long response times, attacks from overseas internet bots and somewhat stale content which limited its usage. Numerous improvements in website infrastructure were implemented in 2023 to address these problems. In addition, website content has become more dynamic with frequent updates.

- Specialized website caching and image optimization software was implemented to pre-stage the pages of our website so that they can be immediately delivered to its visitors.
- To enhance security, block nefarious access attempts and increase page response time, our website was moved to a Content Delivery Network (Cloudflare) for satisfying website viewing requests from visitors. Also, 2 levels of Firewalls were implemented for greater protection.
- Website performance increased from a 1-2 minute response time to 1-2 seconds for most pages. However, website performance can be briefly degraded whenever we are updating pages with new content.
- Several new webpages have been created for Upcoming Events, Online Worship, RaiseRight, the Friendship Soup Kitchen and others.
- A new Top Bar visible on every St. Peter's webpage has been installed to highlight important announcements and upcoming events.
- New search engine optimization schemes were implemented to improve the internet ranking of St. Peter's website so it appears at the top of the first page internet searches (Google, Bing) rather than being buried in subsequent pages.
- Changes to the menu structure and some webpages were made to support viewing from tablets and mobile phones.
- The website gets 50-100 visits and 200-300 page views each week.
- Website backups are now run daily and stored offline in Google Drive (cloud storage).

Streaming of Worship Services

- The conversion to Frontier fiber-optic internet resolved many problems with the streaming of our worship services, most notably the dropped connections and stutters that made the experience frustrating even for the most patient of watchers.
- Worship services are now simultaneously streamed to both Facebook Live and YouTube and can be watched live or later on either platform.

- The Sunday Bulletin, Lectionary and Book of Common Prayer are now available online at our website's Worship Online page for streamers (and for those who want a sneak preview).
- A Tech Team has been formed to start streaming at the beginning of worship.

Sanctuary Sound System

- Many improvements were made to the church sound system to eliminate the loud and startling noises that would intermittently erupt though the speakers.
- Erik Barber's expertise was invaluable for reconfiguring the sound system, simplifying the controls at the sound mixer, removing problematic equipment and installing new microphones.
- Two audience microphones were set up to capture congregational singing and responsive participation during worship. This greatly enhanced the streaming experience for those watching at home. Prior to this, streaming sounded flat and as if the sanctuary was empty because only those wearing microphones or standing at the lectern could be heard by those watching online.
- A new lapel microphone (lavalier) was acquired for use by Deacon Jesse or others. The old and problematic handheld microphones were decommissioned.

Fundraising

When we set up the budget for 2023, we set a fundraising goal of \$10,600. We anticipated that we would raise \$3,500 through Building Use, but the remaining \$7100 needed to come from other sources. Given the amount we needed to raise, Mary Waitt, Ingrid Menon, Sandy Bell, and Barbara Hoff met to discuss ideas. The Vendor Fair and a few social/fundraising parish events were already planned, so we looked at other ideas.

The new idea that seemed most viable and involved the least amount of effort was RaiseRight, especially because we were told Wapping Church raised thousands of dollars and because it's an ongoing program rather than a one-time fundraiser. RaiseRight is a program where people buy gifts cards (physical or e-cards) through the RaiseRight website or app for retailers where they already shop, and the church gets a rebate on each card purchased. The cost to the purchaser is a very small processing fee. The rebate we receive is generally around 4%, but it ranges from 1.1% for Amazon to 16% for LL Bean. It took us a couple of months to complete the paperwork, and in September the Vestry successfully piloted it before rolling it out to the whole parish in October. From September to December, we raised about \$360 from 10 participants.

The Vendor Fair's primary source of income is the fee the vendors pay us for their tables. In addition, we run a Teacup Raffle, serve lunch, and sell baked goods. We earned about \$1800 in 2023. This event requires administrative effort up front including sending out the letters, tracking who responded, publicity, etc. as well as purchasing everything for the baked goods and lunch. Then there's everything that has to be done the day before and on the day of the event. Rev. Anne did much of the initial administrative work, and when she went on sabbatical Diane Fornuto rallied a support team to take care of the rest. With their help and the many 'day of' volunteers, the event was a big success, raising about \$1800.

Building Use fees were \$5075, \$1575 more than we budgeted. This is a relatively passive way for us to raise money and we are looking into ways to expand it.

ECCT let us know about a few other potential ways to raise money, including leasing our church roof for one or more 5G cell antennae. After the parish approved this potential use of our building, we filed the necessary paperwork. At this time, the vendor is working in other areas of the state and has not evaluated our property for use.

How can you help in 2024?

- 1. Participate in the RaiseRight program it's a great way for you to contribute to our church with almost no cost to you.
- 2. Help with the Vendor Fair. The good news is that the word is getting out that this is a good event early in the craft fair season, but that means there is more work for us to do. If you are interested in helping with any part of the Vendor Fair, please let Rev. Anne know. Also, please come to the event it's important that we have the foot traffic to encourage the vendors to come back plus there are fun and delicious things to pick up!
- 3. Other Ideas. Do you have an idea for a fundraiser that you would like to help investigate and organize? Let Barbara Hoff know.
